

## ACT 48 of 2003 an expansion of the Education Improvement Tax Credit Program

### Established a Pre Kindergarten Program:

**\$5,000,000 set aside for Pre Kindergarten  
Scholarship**

- ◆ Businesses will receive a 100% credit for the first \$10,000, and up to a 90% credit on the remaining amount of the contribution.
- ◆ Requires only a 1 year commitment!
- ◆ Businesses can apply for up to a \$100,000 in credits.
- ◆ The school must be within the Commonwealth of Pennsylvania.

### Expanded the K through 12 Program:

**Added \$10,000,000 to the EITC Program.**

New Breakdown of Credits:

- ◆ \$26,666,666 to Scholarship Funds.
- ◆ \$13,333,333 to Educational Improvement Organizations.
- ◆ Businesses can increase their Credit from \$100,000 to \$200,000 per fiscal year for the K through 12 program.

These are the taxes in which the credit can be applied:

- ◆ Corporate Net Income Tax
- ◆ Bank & Trust Company Shares Tax
- ◆ Insurance Premiums Tax
- ◆ Capital Stock Franchise Tax
- ◆ Title Insurance Company Shares Tax
- ◆ Mutual Thrift Institutions Tax

**A business may apply for a combined total of \$300,000 if they participate in both the Pre Kindergarten & K through 12 programs.**

The Learning Center is an alternative learning facility located in Bradford, Pennsylvania. The school's main objective is to provide a learning environment that best suits the individual student. Each child is encouraged to utilize his/her abilities to expand their potential to develop good problem solving skills, and to be an independent learner. Socially the school believes children will develop self confidence through positive interaction.

The Learning Center began operations in 1984 and is celebrating 20 years of service

to the community this year. There are 122 students in pre- kindergarten through the sixth grade enrolled in the school for the 2003-2004 school term. With 6 full-time teachers on staff, as well as several part-time staff members, the school offers Spanish, Physical Education, Art and Computer, in addition to a traditional curriculum.

Ellen Mialky, Director of The Learning Center, has been working with families and students since the school was opened 20 years ago. She believes that the EITC program has meant the survival of

the school and gives the school stability it never had before. It has helped the enrollment and has broadened the base of the children that attend the school. The EITC has allowed families of all income levels to choose the best educational surroundings for their child.
